Pet Owner's pet shall be deemed abandoned in the pet Owner fails to pick up the pet on the day for pick up indicated above, or if pet Owner fails to pay applicable charges. If the pet is not picked up and all charges settled by payment within seven (7) days from the date Barks Fifth Avenue mails to pet Owner (to the address indicated above) written notice that pet Owner's pet is considered abandoned, Barks Fifth Avenue may either sell the pet pursuant to Barks Fifth Avenue's lien rights or may deliver the pet to a humane society as an abandoned pet and Barks Fifth Avenue shall have no further responsibility for the pet. Pet Owner shall remain liable for unpaid charges, including boarding charges at the rates indicated above (or at Barks Fifth Avenue's standard boarding rates) until the pet is sold or delivered to the humane society. In addition, pet Owner shall pay all court costs and reasonable attorney's fees and costs of collection.

Pet Owner agrees to pay Barks Fifth Avenue for services rendered based on the rates set forth above. Any services provided by Barks Fifth Avenue for which rates are not specified above shall be billed at Barks Fifth Avenue's standard rate schedule at the time services are rendered. Pet Owner also agrees to pay for any other amounts attributable to pet Owner's pet and the care of pet Owner's pet, such as special feed or nutritional supplements, special care or handling, and other services or supplies provided by Barks Fifth Avenue. Barks Fifth Avenue may require payment in advance or at the time services are rendered or may require that payment be made before the pet Owner's pet is returned to the pet Owner. Otherwise, pet Owner will be billed for services pursuant to this Agreement and payment is due upon receipt of the billing statement. Pet Owner will pay all of Barks Fifth Avenue's expenses in collection, including collection agency fees, attorneys' fees and costs, and other costs. Barks Fifth Avenue may refuse service if billings remain unpaid. Pet Owner hereby grants Barks Fifth Avenue a lien against any pet in its possession for unpaid charges and Barks Fifth Avenue may, at its option, retain possession of pet Owner's pet until all charges are paid.

It is understood by Barks Fifth Avenue and Owner that all provisions of this agreement shall be binding upon both parties hereunto for this visit and for all subsequent visits. This contract contains the entire agreement between parties.

This agreement is between Barks Fifth Avenue (Barks Fifth Avenue) and the above-named pet Owner and relates to services to be rendered in reference to the above-named pet. Pet Owner hereby requests Barks Fifth Avenue to provide the services marked above. Pet Owner agrees to deliver and pick up Owner's pet during Barks Fifth Avenue's normal business hours on the dates indicated, unless prior arrangements are made. Pet Owner agrees that if his or her pet is picked up after 12:00 p.m. pet Owner shall be charged for an additional day's boarding charges. Pet Owner shall be liable for any injury or damage to Owner's pet while in transit to or from Barks Fifth Avenue's facility. Barks Fifth Avenue may refuse to accept (or may terminate this Agreement and require pet Owner to immediately pick up) any pet whose behavior could jeopardize the health or safety of Barks Fifth Avenue personnel or other animals.

Upon arrival, the pet will be examined by Barks Fifth Avenue for fleas, ticks, and other minor health problems. If minor health problems are found, the pet will be bathed or treated at pet Owner's expense. If other problems are present, Barks Fifth Avenue may in its discretion refuse to accept the pet until such conditions are corrected. Pet Owner represents to Barks Fifth Avenue that the pet is in good health and that all vaccinations are current. If the pet becomes ill, or if the state of its health otherwise requires professional attention while in Barks Fifth Avenue's care, pet Owner hereby grants Barks Fifth Avenue the authority, in its sole discretion, to engage the services of a veterinarian of Barks Fifth Avenue's choice. Charges by Barks Fifth Avenue or any veterinarian for services performed shall be paid by pet Owner. Pet Owner hereby requests Barks Fifth Avenue to administer, or to arrange on behalf of pet Owner, the following vaccinations:

All services shall be provided at Barks Fifth Avenue's facility in Harris County, Texas, unless otherwise indicated in this agreement. Barks Fifth Avenue agrees to exercise reasonable care to maintain a clean, safe, and secure environment for the pet while the pet is in Barks Fifth Avenue's custody. Provided that Barks Fifth Avenue has exercised reasonable care, Barks Fifth Avenue shall not be liable for loss or damage to pet Owner's pet, from any cause, including specifically but without limitation, disease, theft, fire death, escape, or injury. In addition, Barks Fifth Avenue shall not be liable for harm to persons, other animals, or property caused by pet Owner's pet and pet Owner shall indemnify Barks Fifth Avenue from any liability for any damages caused by pet Owner's pet.
